**ORDER**

In supersession of this office Order No.DPI-UTA3-11(1)2008, dated 4.4.2008, approval is hereby accorded to the revision of rates of Fee and Pupil's Funds in respect of students for 9<sup>th</sup>, 10<sup>th</sup> and 10+1, 10+2 all streams in respect of all the Government as well as Privately Managed Government Aided Schools of U.T., Chandigarh from the academic session 2008-09 subject to admissibility of other benefits/concessions:

1. No fee and funds upto VIIIth Class for both boys and girls.
2. No tuition fee from girl students (Model & Non-Model).
3. SC/ST boys are also exempted from Tuition Fee.
4. Funds will be charged half from SC/ST students both boys and girls.
5. Smart sections students will be charged Rs.150/- per month in addition to the normal fees and funds.
6. No tuition fee will be charged from all boys students belonging to Muslims/Christians/OBC, handicapped, Freedom Fighters Ex-serviceman, Widows, divorcees having family income below the limit of 1.5. lacs per year.
7. Boys students of all rural schools will also be exempted from half tuition fee if they provide a proof of residence and of income limit below Rs.1.5 lacs per annum.
8. These rates of Fee/Funds shall be valid for minimum three years.




