

#### ORDER

In supersession of this office Order No.DPI-UTA3-11(1)2008, dated 4.4.200\$, approval is hereby accorded to the revision of rates of Fee and Pupil's Funds in respect of students for 9th, 10th and 10+!. 10+2 all streams in respect of all the Government as well as Privately Managed Government Aided Schools of U.T., Chandigarh from the academic session 2008-09 subject to admissibility of other benefits/concessions:

- No fee and funds upto VIIIth Class for both boys and girls.
- No tuition fee from girl students (Model & Non-Model). .2.
- SC/ST boys are also exempted from Tuition Fee. 3.

Fund

- Funds will be charged half from SC/ST students both boys and girls. 4.
- Smart sections students will be charged Rs.150/ per month in addition to the normal 5.
- No tuition fee will be charged from all boys students belonging to Muslims/Christians/OBC, handicapped, Freedom Fighters Ex-serviceman, Widows, 6. divorces having family income below the limit of 1.5. lacs per year,
- Boys students of all rural schools will also be exempted from half tuition fee if they provide a proof of residence and of income limit below Rs.1.5 laes per annum. 7.
